# AARTI TIKOO SINGH New Delhi

India on Tuesday started the preparations for evacuating the Indian nationals trapped in Wuhan city, the epicentre of the novel coronavirus (2019-nCoV) epidemic, placed under a lockdown.

In a series of tweets, Ministry of External Affairs spokesperson Raveesh Kumar said: "We have begun the process to prepare for evacuation of Indian nationals affected by the situation arising out of nCorona-2019 virus outbreak in Hubei Province. Our embassy in Beijing is working out the logistics and is in touch with the Chinese government and our nationals on this matter."

Over 500 Indian students are studying in colleges and universities of Wuhan city in Hubei province. However, a large number of them had departed for home just ahead of the outbreak of the 2019-nCoV.

# 633 people under observation in Kerala

THIRUVANANTHAPURAM: A total of 633 people, who returned to Kerala from China in recent days, are under observation for possible exposure to the novel coronavirus, state Health Minister K K Shylaja said on Tuesday. Of the 633, seven are under observation in isolation wards at different hospitals, according to officials. The situation in the state was under control but the state

needs to be vigilant, the minister told reporters. "A total of 633 people are under observation in the state.

As of now everything is under control. But we need to remain vigilant until the World Health Organisation says its safe," the minister said.

She asked those who have returned from China or other affected areas like Nepal or Sri Lanka to approach the health department without any hesitation.

"Those who have returned from China should approach the health department and follow the instructions of the officials. It has been learnt that the particular virus will be inactive in the body for a few days initially. So it is better to stay under observation," the minister said.
